# SUBJ: Annual MANDATORY VA Fee Appraiser Training Conference

**1.** <u>**Purpose:**</u> This is to announce our next mandatory VA fee appraiser training sessions. Our 2006 mandatory fee appraiser training conferences for all VA fee appraisers within the jurisdiction of the Cleveland RLC will be held on the following dates, at the following locations:

May 10th, in Lansing, MI (The Greater Lansing Association of Realtors)

May 16th, in Indianapolis, IN (Indiana Government Center South Building)

June 9th, in Cleveland, OH (Cleveland Regional Office)

June 15th, in Pittsburgh, PA (Pittsburgh Regional Office)

June 27th, in Philadelphia, PA (Philadelphia Regional Office)

June 29th, in East Brunswick, NJ (Veterans of Foreign Wars (VFW))

2. <u>When will the conference take place?</u> The conference will be held from 9:00 a.m. to 3:00 p.m. Registration will begin promptly at 8:00 a.m. Attendance is mandatory, and you must bring a copy of your current Real Estate Appraiser license. All Fee Panel Appraisers appointed within past 12 months, and <u>did not</u> attend any of our fiscal year 2005 meetings or the October 19, 2005 meeting will be required to attend an additional one-hour orientation beginning at 3:00 p.m.

**3.** <u>Can I attend the training at another location?</u> You may attend a training session at any of our other locations if you are unable to attend your local meeting, provided there is space available. Space is limited in some locations, so you must make conference reservations with the Regional Loan Center in Cleveland if you plan to attend out of your area. Priority will be given to the local fee panel members. Please e-mail reservations to: **325cnv@vba.va.gov**.

**4.** <u>Will there be security screening?</u> You will be required to show picture identification, such as a driver's license, for entrance at some locations. Only those people on our list of approved VA fee appraisers and specially invited guests will be admitted. Due to security requirements, there are no facilities for additional persons to attend or to wait for you until the conference ends. You may have to pass through a metal detector, so please be careful what you carry into the building.
