SUBJ: CONSOLIDATION OF PITTSBURGH C&V WORKLOAD TO THE CLEVELAND RLC

- 1. PURPOSE:** The Department of Veterans Affairs (VA) is continuing our reorganization drive to provide more efficient and cost-effective service to our veterans and to the mortgage industry.
- 2. APPRAISAL WORKLOAD TRANSFER:** Effective October 1, 2002 the Cleveland Ohio Regional Loan Center (RLC) will process all Pittsburgh VA work relating to existing and proposed valuation determinations and compliance inspections, liquidation appraisals, LAPP related oversight functions, and LAPP Lender SAR processing. Cleveland RLC will also be responsible for all Pittsburgh SAH processing (including SAH compliance inspections), and all necessary field review work.
