SUBJ: Notification of A-76 Study Industry Day Broadcast

1. **Purpose.** The purpose of this letter is to notify Property Management Program Participants of the A-76 Study Industry Day broadcast scheduled for January 25, 2000, from 1:00 pm through 4:00 pm EST.
2. **What Is Industry Day?** The purpose of this Industry Day is to allow stakeholders and other interested parties an opportunity to ask questions and submit comments and suggestions that may be considered in the development of the final Performance Work Statement (PWS). The goal is to gain additional ideas and perspectives so that the scope, approach, and intent of the PWS, which serves as the statement of work, are clear and concise.

During the broadcast, the Director of Loan Guaranty Service, the A-76 Project Manager, the VA Contract Officer and a staff member from Booz-Allen and Hamilton (the A-76 Study consultant) will provide a brief overview of the A-76 process and will conduct a detailed interactive discussion of the draft PWS. All attendees are responsible for obtaining OMB's A-76 Circular and having a basic understanding of the A-76 process prior to the broadcast as the broadcast panel will not entertain questions on A-76.
