**SUBJ:** Loan Guaranty Information Videos

**PURPOSE**

The purpose of this circular is to announce the availability of six new training videos for Loan Guaranty employees and other appropriate audiences. The videos are being shipped to Regional Loan Centers and Eligibility Centers under separate cover. Additionally, copies of one of the videos, "*Automated Certificate of Eligibility (ACE) Update*" are being shipped to all regional offices.

**BACKGROUND**

In addition to producing monthly satellite broadcasts, Loan Guaranty in Central Office produces a series of short videos on a variety of topics to help keep employees, lenders, and veterans informed of program changes. Six new videos are being shipped at this time; two more videos are scheduled for production and will be shipped before the end of the year.

**INTENDED AUDIENCE**

Each video was produced with a particular audience in mind; however, you may find some of them useful for wider audiences than originally intended. If you find a particular tape useful for a wider group, please let us know. The videos are short, ranging from 10 to 20 minutes in length, and are closed captioned for the hearing impaired.
